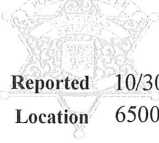

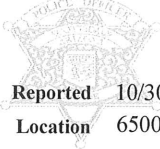

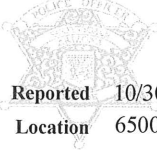

### Notes / Narratives

NARRATIVE: On 103012, 0804-0817, OF/Jason Shelton displayed disruptive behavior by interfering with the operation of a manned, stationary City of Scottsdale-contracted, American Traffic Solutions (ATS) Photo-RADAR van by blocking the cameras, and causing the camera operator within to cease operations. at 6500 E Osborn Rd, Scottsdale, Arizona.

INVESTIGATING OFFICER'S SUPPLEMENT: On 103012, 0817, I was on patrol in the City of Scottsdale driving a fully marked police cruiser and wearing a regulation blue uniform with badge, belt and gun. I heard Detective Chilzuike radio that he had observed a subject having a "heated" argument with a photo RADAR van operator in the area of the Pauite Neighborhood Center, 6535 E Osborn Rd. Officers Bolles, Garcia and I responded.

I arrived and observed Bolles talking to a white male subject on the sidewalk. He was wearing a black bandana, black shirt and tan cargo pants. The subject was also holding a phone camera up pointed at Bolles. The van was positioned 30 feet to the east facing east on a small clearing on the south side of the roadway - the operator was standing near the back of the van. The subject, later identified as OF/Jason Shelton, seemed agitated as he spoke with Bolles.

I contacted the van operator, later identified as W [REDACTED] RADAR. [REDACTED] stated that he is a contractor with American Traffic Solutions (ATS) and is a certified RADAR camera operator. [REDACTED] stated that at approximately 0804 hrs, he was seated inside the mid-section of the Van #2 facing the rear of the van. His laptop and photo equipment is installed in front of him and to his right, which was street-side. [REDACTED] stated that he was observing traffic through the back window and monitoring his laptop, which had a split screen of two cameras - one was facing west from the rear of the van, which captured the face of the driver of an oncoming, offending vehicle, and the other was facing east to capture the license plate number of offending vehicles.

[REDACTED] stated that he saw Shelton walking west on the sidewalk on his east camera. Shelton was wearing a black bandana, dark sunglasses, black shirt and tan cargo pants. [REDACTED] looked to his right and saw Shelton walk up to the van's sliding door/window facing the street. [REDACTED] stated that Shelton then looked inside the van but was not able to see him because he has a black shade blocking public view.

[REDACTED] stated that as Shelton looked into the window he yelled, "Thieving motherfuckers!" [REDACTED] stated that he watched Shelton as he walked around to the rear of the van and put a phone camera up to the van's camera. [REDACTED] stated that Shelton stood in front of the van's camera and blocked his view of oncoming cars for about 10 minutes and continued to film with his cell phone camera. [REDACTED] stated that after that Shelton walked around to the other side the van, and he lost visual contact with him. Fearing for his safety and not knowing exactly where the subject was located, [REDACTED] exited the van and confronted Shelton as he stood near the rear.

[REDACTED] stated that Shelton stepped back and seemed surprised. [REDACTED] stated that Shelton called him a "thieving mother fucker" and ranted about the government taking everyone's money. [REDACTED] stated he told Shelton that the vans were used to save lives and

that speeders were the problem. [REDACTED] stated that Shelton filmed the entire incident. [REDACTED] stated that Shelton continued to talk about the photo-RADAR and the redlight RADARs, and how they rip people off and are "rigged". [REDACTED] stated that he got back in his van but watched Shelton as he stood near the rear of the van. [REDACTED] stated that minutes later the police arrived.

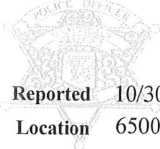
[REDACTED] stated that he was never threatened by Shelton but his duties were interfered with for about 15 minutes because of Shelton standing in front of the van cameras, which prevented him from tracking offending cars. It should be noted that traffic was moderate to heavy during this investigation. I advised Officer Bolles of my investigation and he arrested Shelton for disorderly conduct. I impounded Shelton's cell phone as evidence. I recorded my interview with [REDACTED] See Det Chilzuik and Officer Bolles supplements for further information. This concludes my report.

### Supplement Notes

On 10/30/12 at approx 0815 hours I responded to a call for a disturbance in-progress at 6535 E Osborn.

Call comments stated: NEAR PIUTE CENTER - HAVING A DISCUSSION WITH PHOTO GUY "HEATED".

Upon arrival I recognized the subject, later identified as Jason Shelton from previous booking, from an incident earlier that morning regarding myself running radar. That morning he was filming me on his phone and yelling about me being overpaid and robbing people of their money. I had to tell him several times to stand a safe distance back from my vehicle and not to stand in the middle of the street. He tried to push the envelope with me that morning on how close he could get and how much he could obstruct.

Immediately Shelton began to ask what he was being accused of and making statements about public service and the police in a negative manor. I asked for his name and he refused. He was holding his phone up to record and being uncooperative but not combative at this time. Ofc. McDonough arrived and spoke to the original witness and the operator of the photo van. See his supplement for further details. The location of the incident was in-front of the Paiute Neighborhood Center where children gather to catch the bus and attend classes.

Ofc. McDonough then informed me after speaking with the witnesses that we had enough probable cause to arrest Shelton for disorderly conduct- disruptive behavior. He was arrested at 0827 hours with his hands behind his back double locked and checked for fit. A search incident to arrest was negative for contraband. He was placed into the backseat of my patrol car and seat belted in for transport to the District Two Jail. Upon arrival to the Jail he was turned over to the detention staff for processing. It was learned Shelton did not have and could not provide a local address. He was therefore held in-custody regarding his residency in the State of Kansas. This concluded my involvement in the incident.

### Supplement Notes

On 10-30-2012 at approximately 0815 hours, I was working as a member of the High Enforcement Arrest Team (HEAT). I was dressed in plain clothes and was wearing a black load bearing vest which contained the letters "POLICE" in yellow lettering on both the front and back of the vest which are clearly visible. I was operating a semi marked vehicle (lights/sirens).

I was conducting surveillance on an unrelated case in the vicinity of Pinto Lane and Osborn Road. I was parked facing south on Pinto lane just north of Osborn Road. Officer E. Bolles #1210 informed members of my unit and I of a white male subject walking north on 68th Street. He described the male wearing a black colored bandana on his head, a long sleeve black shirt and khaki colored pants. The subject, using his cell phone, was videotaping Officer Bolles #1210 while he ran radar on 68th Street.

I re-acquired this subject (later identified as Jason Shelton) walking westbound on Osborn Road. Shelton continued walking past my position and slowed right after he crossed 66th Street. I observed a marked Scottsdale Police radar van parked facing eastbound approximately 80 yards west of 66th Street on the south side of Osborn Road. I know the radar van is occupied by personnel who manage the cameras and equipment inside. Shelton walked up to the van and was now holding what appeared to be a cell phone in his hand. Shelton walked up the driver's door and leaned over the windshield of the vehicle holding the cell phone up to the windshield as if he was videotaping. Shelton then walked alongside the driver's side of the vehicle and walked to the back door of the van and continued videotaping the vehicle. He then walked to the passenger side of the vehicle and began walking toward the front of the van again.

I then observed a male exit the van on the passenger side of the van and stood beside the front passenger door. I witnessed the employee make verbal contact with Shelton and he immediately became animated and raised the cell phone and continued videotaping the employee as they spoke. I observed Shelton walk toward the employee and then walk back several times and continued being animated by raising his arms and elevating the cell phone to videotape the employee. It appeared Shelton was interrupting the employee from safely operating the photo radar van.

Marked patrol officers were requested to respond to the area in order to de-escalate the situation. Officer Bolles and Officer McDonough arrived to the area, see their supplement for further.
